All holders whose passport includes also married surname beyond original family one, have to mandatorily insert (both for the reservation of cruise as well as for any possible Visa application independently arranged) the one present in the barcode at the bottom of same page. We have been experiencing problems at various ports where Immigration formalities are performed with the new automated system as very often the surname in the passenger's list is not corresponding to the one in the Visa; at the moment of swiping the passport in the reading machine the info sorting out is the one of the barcode.

Covid Insurance is no longer mandatory, but it is still recommended to have a travel and medical insurance that covers against risks related to cancellation, trip interruption, repatriation costs, medical assistance and other related expenses, as well as hospitalization.

It is the responsibility of each guest to ensure they meet the requirements of any country they may be traveling through before, during and after the cruise.
