Formulario online visado de tránsito – recomendaciones para el solicitante

Esta guía se actualizará cada vez que haya actualizaciones en el portal del MOFA*

•!• Antes de solicitar el e-Visa* por favor tenga en cuenta las siguientes recomendaciones:

1. El visado de tránsito marítimo requiere que el pasajero disponga de un billete de ida y vuelta.
2. Recomendamos iniciar el proceso de solicitud del visado en casa antes del crucero.
3. Es necesario disponer de una conexión estable a internet.
4. Durante el proceso de petición del visado, se enviará un correo de verificación a la dirección de e-mail indicada para activar el usuario; en el caso de que NO se reciba dicho correo, será necesario darse de alta con un e-mail diferente utilizando un proveedor de servicios de correo electrónico más popular.
5. Disponer de una tarjeta de crédito aceptada internacionalmente (puede ser necesario ponerse en contacto con el banco emisor para confirmarlo).
6. Es importante asegurarse de que no hay ningún problema con la tarjeta de crédito ya que se realizarán 3 pagos. (se recomienda utilizar VISA y MasterCard).
7. La misma tarjeta de crédito solo se podrá usar para realizar 25 pagos. (En caso de que haya familiares o acompañantes)
8. Es importante asegurarse de tener acceso al mismo número de móvil registrado en el banco de la tarjeta de crédito para la verificación bancaria.
9. Es importante asegurarse que el nombre y el apellido correspondan a los que aparecen en el pasaporte del solicitante.
10. Es importante asegurarse que la foto personal se ajusta a los requisitos.
11. Es importante asegurarse de elegir el tipo de visado correcto (Transit Sea Visa: visado marítimo de tránsito).
12. En caso de problemas técnicos, es posible ponerse en contacto con el servicio de asistencia técnica del MOFA en el siguiente número: (00966920011114)
13. Una vez aprobado el visado por las autoridades, el mismo será enviado al solicitante a través del correo electrónico registrado.
14. Es importante imprimir el visado electrónico.

IMP: cualquier solicitante que no siga las presentes recomendaciones podría verse denegado el visado



Visa Portal mandated to provide on-line services. You shall pay to Visa Portal for processing visa applications online ("The Services"). You are fully aware that the Services shall only include the electronic processing of the visa applications, and obtaining it's approval or rejection, but shall not include the regular government visa charge which shall be paid subsequently getting a visa application approved to the Saudi Embassy or Consulate (if any). The payment can be made online through (Visa & MasterCard) credit cards. All fee payments made using the e-payment System for "Banking Service Fee" and to the benefit of Visa Portal for "Visa Processing Fee" are NON-REFUNDABLE.

Paso 5: Después de haber leído el siguiente acuerdo, haz click en "Agree" para indicar que estás de conforme con el mismo.

Agreement

I, the undersigned, hereby agree to have my fingerprint & iris data (biometrics) captured as part of the application procedure for an entry visa to the Kingdom of Saudi Arabia. I further agree and declare as follows:

- I acknowledge that all of the information I provided are true and reliable. In addition, I pledge to abide the laws and rules of the Kingdom of Saudi Arabia, and respect the customs and Islamic traditions of its people during my stay. I acknowledge my understanding that the specialized authorities in the Kingdom of Saudi Arabia have the right to deny my entry and to send me back to where I came from if I did not comply with the rules and laws, or if the information under which I received my visa proven to be incorrect.
- I am fully aware that all intoxicating substances, narcotic drugs, indecent materials and publications, as well as publications related to any religious beliefs or political tendencies that contradict with Islam are prohibited in the Kingdom of Saudi Arabia.
- I am fully aware of the procedures and controls regarding the batch-release and clearance of medicines, containing narcotic or psychotropic substances that are possessed for personal use by patients arriving and departing from The Kingdom, such procedures and controls are provided in the link below: http://www.sfda.gov.sa/ar/drug/drug_reg/pages/drug_reg.aspx I am also aware that if these regulations and controls are transgressed, I shall will be subjected to sanction and penalties provided for in the Law of Combating Narcotics and Psychotropic Substances and its implementing regulations.
- I have never been deported from The Kingdom of Saudi Arabia or any other GCC countries, nor that I have violated their rules.
- I pledge to stick to the kind of visa I was provided with and to its terms and duration, and I shall leave the country before the stay specified in the visa expires. I am also fully aware of my violation to the rules in the Kingdom or entry visa shall subject me to a penalty and the application of punishments stipulated by the laws regulating the process of handling people coming to the Kingdom with visas for Hajj or Umrah and others issued by Royal Decree No (m / 42) , on 18 / 10 / 1404 H and amended by Royal Decree No (m/9) on 1/5/1420 H, as well as sanctions on violators of residency and work regulations promulgated by the Council of Ministers resolution No (140) on 6/5/1434 H. .
- I acknowledge the right of Saudi authorities to repatriate me from the port of entry at my own expense or deport the Saudi territory after entering it, and I acknowledge the right of the Saudi authorities to apply the penalties provided by Law if proven that after I got my visa or residence permit , I have submitted incorrect papers or documents or provided false statements to any Saudi competent authority at home or abroad in order to obtain for myself or for someone else a visa for entry or residence permit or any other official visa or being a contributor or partner in providing such information or documents that do not match the truth.
- I acknowledge that drug dealing or smuggling drugs into the Kingdom is a crime punishable by death penalty.
- While coming to the Kingdom or departing therefrom, I shall be committed to declare any cash or precious metal and the like that worth up to "SAR 60,000" sixty thousand riyals or more or equivalent foreign currencies. Further, I shall be pledged to declare any valuable luggage while entering the Kingdom and pay any due customs duties and taxes. In case of violation, this may expose me to legal accountability and application of the laws applicable in the Kingdom
- I acknowledge that the regulations in Saudi Arabia classify giving a bribe regardless of the amount, as a criminal offense that subjects the offender to imprisonment or the payment of a fine or both
- I acknowledge and pledge again that all written information shall be correct and I take full responsibility for it, and if it is proven otherwise -or my name appears to be included in a list specifying the prohibited people -, then my request shall be rejected, or my visa shall be canceled automatically if it is granted, or I shall not be allowed to enter the Kingdom of Saudi Arabia if I had a valid visa . Moreover, I acknowledge the right of Saudi authorities to deport me back to the port of entry at my own expense and I shall not have the right to claim compensation.






